




MISSION

Our vision is that all Texans live free from abuse.






Texas Advocacy Project is a nonprofit organization providing **FREE** legal and social services to survivors of:

Provided free legal services to 5,042 primary survivors in power-based abuse cases











WHY WE HELP


ASSISTED PRO SE SERVICES

WHAT IS "PRO SE"?

• A person who acts as his or her own attorney is a *pro se* litigant.

ASSISTED PRO SE (APS)

• Our attorneys help victims to represent themselves pro se in order to free themselves from their abusers.






ASSISTED PRO SE SERVICES

What our attorneys can do for your clients:

- Explain the services available to them
- Discuss legal options
- Safety planning
- Draft all court documents
- Draft instructions and script for clients to use in court
- Guide clients through the legal case step-by-step





APS ELIGIBILITY REQUIREMENTS & WHEN WE MAKE EXCEPTIONS

- Clients must have applied for and been denied services by their local legal aid organization,
- Clients must have a telephone number and mailing address that can be used regularly and successfully by staff attorneys,
- Clients must have a good address for the opposing party if there are children involved, AND
- Clients must be capable of speaking before a judge in a courtroom.




TIMING ISSUES

Clients in the following situations *may not* want to proceed with litigation while the situation is ongoing:

- Clients with active and open CPS cases.
- Clients with active and open Attorney General cases.
- Clients who have had a child born during the marriage whose father is not the current spouse and there has not been an adjudication of paternity for that child.
- Clients that are currently pregnant. Clients can apply after the birth of the child with appropriate acknowledgment/denial of paternity documentation.
- Clients can reapply once the case is closed and/or the client obtains orders and supplies a copy to their assigned attorney.







TIMING NON-ISSUES

The following DO NOT create issues with moving forward:

- Clients that have been involved with CPS, but the case is now closed.
- Clients that have been to the Attorney General's Office and now have a final order that establishes child support and visitation.









VIRTUAL LEGAL CLINICS

- Virtual Legal Clinics have been tested in 30 shelters.
- Clients can receive face-to-face legal advice and documents in real time using virtual technology.
- Attorneys can make changes to documents and make them available to the client instantly on the computer so she can print them out and take them to court.








CRISIS CONSULTS

MODEL PROGRAM

- TAP attorneys work with local law enforcement and the judiciary in Austin to assist victims of crimes involving family violence.
- TAP attorneys contact victims and discuss legal options, offer safety planning, and conduct lethality assessments in the hours immediately after the crime.
- TAP attorneys can prepare EPO paperwork for submission to the court.








CRISIS CONSULTS

- Though this is only available in Austin, TAP provides training statewide on best practices regarding EPOs for law enforcement, victim liaisons, and the judiciary.
- TAP's EPO in a Box is available on our website and can be downloaded.
- EPO forms are available in English and Spanish on our website.





PRO SE PROTECTIVE ORDER PACKET

- Provides victims of domestic violence and sexual assault legal forms to represent themselves in obtaining a protective order.
- Useful when legal services are not available.
- Packets can be mailed to a caller who contacts any of the agencies legal lines or can be downloaded at www.TexasAdvocacyProject.org
- Available in English, Spanish, and Vietnamese






DIRECT LEGAL REPRESENTATION




OUTREACH TO UNDERSERVED & RURAL COMMUNITIES

- Black communities and communities of color






STATEWIDE TRAINING


Our staff and attorneys travel across the State to provide training and ongoing support to programs, the judiciary, community services agencies, and law enforcement officers.

Trainings are **FREE** – both in-person or virtual – and we offer **FREE CEUs!**








ACCESS TO JUSTICE


TAP provides coordination and oversight of statewide legal efforts that serve victims of domestic violence.

- Advocacy within institutions that intersect with victims' issues.









PRO BONO PARTNERSHIPS

- The Assisted Pro Bono Program is designed to assist attorneys taking Pro Bono family violence cases and to recruit attorneys to take more of these cases.
- Attorneys may call TAP to receive input on case strategy or sample legal documents in preparation for a pro bono case.
- TAP is able to review drafted legal documents to provide useful feedback to attorneys.
