Description of Jobs Created There were .50 ARRA NEG jobs created/retained. This total included .35 Community and Social Service Occupations, .07 Business and Financial Operations Occupations, and .08 Office and Administrative Support Occupations. These ARRA National Emergency Grant (NEG) funds will ensure that the Central Texas Workforce Development Board provides, subject to NEG allowable uses, workforce development services to 500 dislocated workers, including the following: Core and intensive services, such as skills and educational assessments, leading to an Individual Employment Plan, job search assistance, or referrals, as appropriate, to other workforce services; Occupational and vocational training services; and Support services, such as uniforms and tools, as well as transportation or other support to address barriers to participation, as determined by a needs assessment. Affected workers from Becon Construction, Inc., Texas Hydraulics, Inc., Alcoa, Inc., and Zachary Holdings, Inc., or other employers as approved by DOL, will have access to the full array of dislocated worker services.
