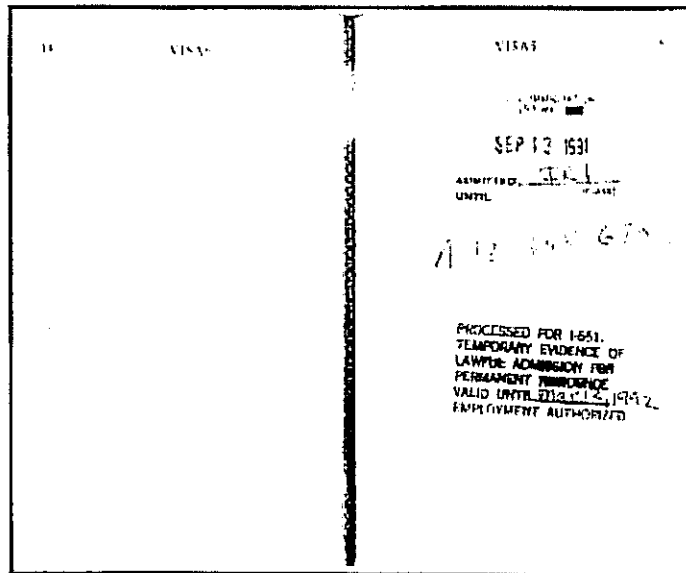

An individual in possession of the departure portion of this document may only be employed if the document bears an "employment authorization" stamp or employment incident to the nonimmigrant classification is authorized with a specific employer (i.e. A-1, A-2, A-3, C-2, C-3, E-1, E-2, G-1, G-2, G-3, G-4, G-5, H-1A, H-1B, H-2A, H-2B, H-3, I, L-1, O-1, O-2, P-1, P-2, P-3, Q, NATO 1-7 and TC). The expiration date is noted on the Form I-94.

Persons who have been convicted of or who have committed a felony or other crime of misdemeanor involving moral turpitude or who have been deported or removed from the United States, other national naturalization laws, or physically defective persons, those affected with lunacy or contagious diseases, and others found to be inadmissible under the immigration laws are subject to exclusion if admitted to reenter, notwithstanding their may be in possession of permits to reenter.
